- ♦ Due to variations in Engine Compartments, bilge equipment and geographic location, some boats may require a larger or an additional heater. Consult your dealer for recommendations specific to your boat and climate.
- ♦ Any boat stored out of the water on a lift or on a trailer will require our BSAT 750 Watt heater.
- ♦ Professional installation is recommended, but complete instructions are included.
